# 1. Environmental Policy Statement

Overall responsibility for the Environmental Policy sits across CWT management functions and is led by the Global Head of ESG and Employee Experience. Reinforcing our commitment to the Science Based Targets Initiative and our journey towards net zero, all directors will ensure that:

- CWT, as a global business travel and meetings specialist, commits to being environmentally engaged and to deliver responsible travel and meetings management services to its customers, thus helping them achieve their own environmental objectives;
